

RESOLUTION NO. 201284 NOV 19 1970

APPROVING MAP OF LARWIN MESA VIEW UNIT NO. 7
SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC
THE PUBLIC STREETS AND PORTION OF PUBLIC STREET
DEDICATED ON SAID MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by GARY L. McCABE, Registered Civil Engineer, and entitled,
"LARWIN MESA VIEW UNIT NO. 7 Being a subdivision of
portions of the Northeast Quarter of Section 25, Township 14
South, Range 3 West, San Bernardino Meridian, and the North-
west Quarter of Section 30, Township 14 South, Range 2 West,
San Bernardino Meridian, all being in the City of San Diego,
County of San Diego, State of California, according to United
States Government survey, excepting all minerals and mineral
rights, oil, gas, and hydrocarbons together with the right
to drill but without the right of surface entry as reserved
by Larwin Company, a California corporation, in Deed recorded
June 16, 1970.", is made in the manner and form prescribed
by law and conforms to the surrounding surveys; that said map
and the subdivision of land shown thereon is hereby approved
and accepted; and said Council hereby accepts on behalf of
the public the public streets and portion of public street,
to wit: Aquarius Drive, Aquarius Place, Bralorne Court,
Lepus Road, Westonhill Drive and a portion of Kelowna Road
for public purposes, and said streets and portion of public
street are hereby declared to be public streets and portion
of public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
