

RESOLUTION NO. 201290 NOV 24 1970

APPROVING MAP OF VILLA BARBADOS UNIT NO. 1 SUB-DIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS AND EASEMENT DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE ABUTTERS' RIGHTS OF ACCESS TOGETHER WITH THE EASEMENTS AS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, and entitled, "VILLA BARBADOS UNIT NO. 1 Being a subdivision of a portion of Rosedale Tract in the City of San Diego, County of San Diego, State of California according to Map thereof No. 825, filed in the office of the County Recorder of San Diego County, January 21, 1897.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the 16 foot pedestrian and non-motor vehicular easement, and the public streets, to wit: Bengal Court, Azores Court, Mantua Court, Montego Place, Montego Drive, Remora Street, Gabacho Drive and Por Techo Court, for public purposes and said easement and streets are hereby declared to be public easement and public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any

and all abutters' rights of access in and to Santo Road, adjacent and contiguous to Lots 1, 2, 3, 5, 6, 7, 99 and 100 and any and all abutters' rights of access in and to Clairemont Mesa Boulevard adjacent and contiguous to Lots 7, 8, 12, 13, 16, 17, 20, 21, 24, 25, 28 and 29, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space designated as Lot "A," and the easement with the right of ingress and egress for the construction and maintenance of sewer facilities, and the non-exclusive parking and utility easement and access thereto over, under, across and through areas designated "parking easements," all as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public easement and public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access together with the easement for open space, the easement with the right of ingress and egress for the construction and maintenance of sewer facilities, and the non-exclusive parking and utility easement, as granted and shown on this

map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
