

RESOLUTION NO. 201292 NOV 24 1970

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the acceptance by the City Manager of that deed of CHRISTIANA OIL CORPORATION, executed in favor of The City of San Diego, bearing date November 9, 1970, conveying to said City an easement and right of way for street purposes through, over and across a portion of Lots 17 and 23 of Rosedale Tract, according to Map thereof No. 825, filed in the County Recorder's Office January 21, 1897 and of Lots 5 to 8 inclusive in Block 19 of the Resub. of Lots 14, 16, 18, 19 and 20 of Rosedale Tract, according to Map thereof No. 857 filed in the County Recorder's Office of San Diego County April 3, 1899 together with a portion of the unnamed streets adjoining said land; a portion of Lots 8, 9 and 13 of Rosedale Tract, according to Map thereof No. 825, filed in the County Recorder's Office of San Diego County January 21, 1897 and of Lot 73 of the Rancho Mission of San Diego, according to Partition Map thereof No. 330 made in the action "Juan M. Luco et al vs. the Commercial Bank of San Diego et al" in Superior Court Case No. 348, and filed in the County Recorder's Office of San Diego County, together with a portion of the unnamed street adjoining said Lots 8, 9 and 13; a portion of Lots 23, 24, 25, 27, 29 and 36 of Rosedale Tract in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 825,

filed in the County Recorder's Office of San Diego County, January 21, 1897 together with a portion of the unnamed streets adjoining said Lots; a portion of Lot 17 of Rosedale Tract, according to Map thereof No. 825, filed in the County Recorder's Office of San Diego County January 21, 1897 and of Lot 5 in Block 19 of the Resub. of Lots 14, 16, 18, 19 and 20 of Rosedale Tract, according to Map thereof No. 857, filed in the County Recorder's Office of San Diego County April 3, 1899 together with a portion of the unnamed street adjoining said land; a portion of Lots 2, 4, 5, 10 and 17 of Rosedale Tract, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 825 filed in the County Recorder's Office of San Diego County January 21, 1897, together with a portion of the unnamed street lying between said Lots 10 and 17; a portion of Lot 15 of Rosedale Tract, according to Map thereof No. 825, filed in the County Recorder's Office of San Diego County January 21, 1897 and Lots 1, 2, 16 and 17 in Block 16, Lots 1 to 4 inclusive and 6, 7 and 8 in Block 18 and Lots 5 and 6 in Block 19 of the Resubdivision of Lots 14, 16, 18, 19 and 20 of Rosedale Tract, according to Map thereof No. 857, filed in the County Recorder's Office of San Diego County April 3, 1899, together with a portion of the unnamed streets adjoining said land, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby



approved; and the lands therein conveyed as Parcel 1 and Parcel 2 are hereby dedicated as and for a public street and the same is hereby named SANTO ROAD, and the land therein conveyed as Parcel 3 is hereby dedicated as and for a public street and the same is hereby named TIERRASANTA BOULEVARD, and the lands therein conveyed as Parcel 4, Parcel 5 and Parcel 6 are hereby dedicated as and for a public street and the same is hereby named CLAIREMONT MESA BOULEVARD.

BE IT FURTHER RESOLVED, that the City Clerk of said City is hereby authorized and directed to file, upon acceptance by the City Manager, the foregoing said deed for record in the office of the Recorder of San Diego County.
