

RESOLUTION NO. 201298 NOV 24 1970

APPROVING MAP OF PENASQUITOS VILLAS UNIT NO. 2  
SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC  
THE PUBLIC STREETS AND ALLEYS DEDICATED ON SAID  
MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN  
DIEGO THE ABUTTERS' RIGHTS OF ACCESS TOGETHER  
WITH THE EASEMENTS AS GRANTED ON THIS MAP WITHIN  
THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by HERBERT I. COOPER, Registered Civil Engineer, and entitled,  
"PENASQUITOS VILLAS UNIT NO. 2 Being a subdivision of a  
portion of Rancho Los Penasquitos, in the City of San Diego,  
County of San Diego, State of California, according to the  
Map accompanying the Patent to said Rancho recorded in the  
office of County Recorder of San Diego County, in Book 2,  
Page 385 of Patents.", is made in the manner and form prescribed  
by law and conforms to the surrounding surveys; that said map  
and the subdivision of land shown thereon is hereby approved and  
accepted; and said Council hereby accepts on behalf of the  
public, the public streets, to wit: Carmel Mountain Road,  
Via Asti, Via Parma, Via San Marco, and Via Rimini and the  
alleys for public purposes and said streets and alleys  
are hereby declared to be public streets and alleys and  
dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on  
behalf of The City of San Diego, a municipal corporation,

any and all abutters' rights of access in and to Carmel Mountain Road, adjacent and contiguous to Lots 19, 20, and 22, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, and the 15.00 foot road easement, all as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets and alleys are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, and the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, and the 15.00 foot road easement as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California
