

RESOLUTION NO. 201301 NOV 24 1970


WHEREAS, on November 6, 1952, Resolution No. 109146 was adopted by the Council of The City of San Diego authorizing a temporary permit for the installation of a 69 KV overhead transmission line until the terms for a period of years was agreed upon; and

WHEREAS, San Diego Gas & Electric Company has agreed to place their transmission line underground and has agreed to a permit for a term of years; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City a Permit For A Period Of Years granting permission to the SAN DIEGO GAS & ELECTRIC COMPANY, a corporation, to use portions of Pueblo Lots 217, 245, 246, 247, 258 and 260 of the Pueblo Lands of San Diego, for underground electrical facilities, for a term of fifty (50) years commencing November 6, 1952 and ending November 6, 2002, at a rental of \$750.00 for the entire term, under the terms and conditions set forth in the form of Permit For A Period Of Years, on file in the office of the City Clerk as Document No. 734100.
