

RESOLUTION NO. 201307

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO DECLARING ITS INTENTION TO PAY OUT OF ITS MUNICIPAL FUNDS THE WHOLE OF THE AMOUNT OF TAXES TO BE DERIVED FROM THAT AREA OF THE METROPOLITAN WATER DISTRICT OF SOUTHERN CALIFORNIA WHICH IS WITHIN THE CITY, FOR THE FISCAL YEAR BEGINNING JULY 1, 1971, IN AN AMOUNT TO BE FIXED IN AUGUST 1971 BY RESOLUTION OF THE BOARD OF DIRECTORS OF THE DISTRICT.

WHEREAS, The City of San Diego is a municipal corporation and a public agency within the meaning of Section 8.2 of the Metropolitan Water District Act of the State of California, as amended (Stats. 1927, ch. 429, p. 694, as amended; Deering's General Laws, Act 9129); and

WHEREAS, the City Council of The City of San Diego desires to declare its intention, pursuant to the provisions of Section 8.2 of the Metropolitan Water District Act, to pay out of the municipal funds of the City the whole amount of the taxes levied by the Metropolitan Water District of Southern California for the fiscal year 1971-72, to be derived from that area of the District which is within the City of San Diego, in an amount to be fixed in August 1971 by resolution of the Board of Directors of the Metropolitan Water District of Southern California; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

The City of San Diego hereby declares its intention to pay out of its water funds the whole of the amount of taxes to be derived from that area of the District which is within the City, in an amount to be fixed in August 1971 by resolution of the Board of Directors of the Metropolitan Water District of Southern California for the fiscal year commencing July 1, 1971 and ending June 30, 1972. Pursuant to the provisions of paragraph (d) of Section 8 of the Metropolitan Water District Act, as amended, The City of San Diego will elect to pay the whole of the amount of the taxes as fixed by resolution of the Board of Directors of the District.

BE IT FURTHER RESOLVED, by the Council that immediately after the adoption of this resolution, and not later than the 10th day of December 1970, a certified copy shall be filed by the City Manager with the Controller of the District, with the County Assessor of the County of San Diego, and with the State Board of Equalization, accompanied in each instance by a statement of the existence of The City of San Diego as a municipal corporation located in the County of San Diego, State of California, a legal description of the boundaries of the City as most recently changed, and a map or plat indicating such boundaries.

BE IT FURTHER RESOLVED, by the Council that concurrently with the certification to the Controller of the District of

this declaration of intention, the City Manager shall cause to be transmitted to the Controller a statement showing the financial condition of the City, the funds from which it is intended that the payment will be made, and the sources of revenue to be used. Not later than the 15th day of December 1970, he shall cause to be filed with the Controller proof that a similar certification has been made to the County Assessor and the State Board of Equalization.
