

RESOLUTION NO. 201313 NOV 24 1970

WHEREAS, The City of San Diego is the owner of portions of Lot 103, La Mesa Colony, according to Map thereof No. 346, filed in the office of the San Diego County Recorder; and

WHEREAS, the City of La Mesa, a municipal corporation, has requested the conveyance of an easement for the purpose of a public street across said property in connection with the realignment of Lake Murray Boulevard; and

WHEREAS, said land is a portion of the El Monte Pipeline Right of Way and the deed conveying said easement will reserve use rights for City's facilities; and

WHEREAS, the purpose for which the real property is required is a public purpose; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code permits the conveyance of City property to public agencies for public purposes without complying with the provisions in the Municipal Code relating to the advertising for bids and auction sales; and

WHEREAS, said City of La Mesa has appraised said property right at the sum of Twenty-Nine Thousand Sixty-Seven and 71/100 Dollars (\$29,067.71), which sum represents the eventual assessment to the City's adjoining ownership; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to the City of La Mesa, a municipal

corporation, in the public interest; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a deed, the form of which is on file in the office of the City Clerk as Document No.

734075, conveying to the City of La Mesa, a municipal corporation, an easement for street purposes across portions of Lot 103, La Mesa Colony, as more particularly described in said form of Deed of Easement.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Department for further handling.
