# RESOLUTION No. 201321

Adopted on DEC 1 1970

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the bid of \$465,667.00 by Callahan Bros., A Corporation, for the CONSTRUCTION OF UNIVERSITY COMMUNITY FIRE-POLICE FACILITY, including the Base Bid and Additive Alternate Numbers 1, 4 and 5 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 733379.
2. That the expenditure of \$493,100.00 is hereby authorized out of the Community Buildings and Improvements Bond Fund (726) and that the expenditure of \$135,900.00 is hereby authorized out of the Capital Outlay Fund (245) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF UNIVERSITY COMMUNITY FIRE-POLICE FACILITY, including the Base Bid and Additive Alternate Numbers 1, 4 and 5 in the City of San Diego, and related costs.
