

RESOLUTION NO. 201332 DEC 1 1970

APPROVING MAP OF BERNARDO GREENS WEST UNIT NO. 4  
SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC  
THE PUBLIC STREETS AND PORTIONS OF PUBLIC STREETS  
DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF  
THE CITY OF SAN DIEGO THE ABUTTERS' RIGHTS OF  
ACCESS, TOGETHER WITH THE EASEMENTS AS GRANTED ON  
THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and  
entitled, "BERNARDO GREENS WEST UNIT NO. 4 Being a sub-  
division of a portion of Rancho San Bernardo, in the City of  
San Diego, County of San Diego, State of California, according  
to Map thereof recorded in Book 2, Page 462 of Patents, Records  
of said County.", is made in the manner and form prescribed by  
law and conforms to the surrounding surveys; that said map  
and the subdivision of land shown thereon is hereby approved  
and accepted; and said Council hereby accepts on behalf of the  
public, the public streets and portions of public streets, to  
wit: Bernardo Vista Drive, Bernardo Center Court, portion of  
Bernardo Center Drive, and portion of Graciosa Road, for  
public purposes; and said streets and portions of streets are  
hereby declared to be public streets and portions of public  
streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on  
behalf of The City of San Diego, a municipal corporation, any

and all abutters' rights of access in and to Regalo Lane, adjacent and contiguous to Lots 2308 through 2320, and any and all abutters' rights of access in and to Bernardo Vista Drive, adjacent and contiguous to Lots 2274 through 2277, 2280, 2281, 2282 and 2287 through 2296, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets and portions of public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map

to the Clerk of the Board of Supervisors of the County of  
San Diego, California.
