

RESOLUTION NO. 201334

APPROVING MAP OF RANCHO SAN CARLOS UNIT NO. 3
SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC
THE PUBLIC STREETS DEDICATED ON SAID MAP, AND
ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO THE
ABUTTERS' RIGHTS OF ACCESS, TOGETHER WITH THE
EASEMENTS AS GRANTED ON THIS MAP WITHIN THIS SUB-
DIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and
entitled, "RANCHO SAN CARLOS UNIT NO. 3 Being a subdivision
of portions of Lots B and F of the partition of a portion of
Lot 70 of Rancho Mission of San Diego, in the City of San
Diego, County of San Diego, State of California, according
to Referee's Partition Map of a portion of said Lot 70 made
in the Action entitled 'San Diego Realty Company, a corporation,
vs. Maria Y. Olvera de Toro et al,' Superior Court Case No.
15191 and on file in the office of the County Clerk of said
County.", is made in the manner and form prescribed by law
and conforms to the surrounding surveys; that said map and the
subdivision of land shown thereon is hereby approved and
accepted; and said Council hereby accepts on behalf of the
public, the public streets, to wit: Bell Bluff Avenue and
Echo Dell Road, for public purposes, and said streets are

hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Mission Gorge Road adjacent and contiguous to Lots 108, 109, 110, 112, 113, 114 and 115, all as granted and shown on said map.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, and the easement for slope rights as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, and the easement for slope

rights as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
