

# RESOLUTION No. 201348

Adopted on DEC 1 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of H. L. WELLS, INC., a California corporation, executed in favor of The City of San Diego, bearing date September 17, 1970, conveying to said City an easement and right-of-way for street purposes through, over and across all of Lot 48 and all of Lot 47, excepting the Southeasterly 10.00 feet thereof in Block 1, Subdivision of Pueblo Lot 277, according to map thereof No. 578, filed January 12, 1889, in the Office of the Recorder of San Diego County, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named HANCOCK STREET.

That the City Clerk of said City is hereby authorized and directed to transmit, upon acceptance by the City Manager, the foregoing said deed to the Property Department for recording and further disposition.
