BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the bid of \$52,000.00 by Deytime Construction Corp., A Corporation, for the CONSTRUCTION OF TORREY PINES MUNICIPAL GOLF COURSE SANITARY FACILITIES, and related improvements (\$48,500.00) and additive item #2 (\$3,500.00) in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 733825.
2. That the expenditure of \$55,000.00 is hereby authorized out of the Capital Outlay Fund (245) Programmed Reserve of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF TORREY PINES MUNICIPAL GOLF COURSE SANITARY FACILITIES, and related improvements (\$48,500.00) and additive item #2 (\$3,500.00) in the City of San Diego, and related costs.
