

RESOLUTION NO. 201364 DEC 3 1970

APPROVING MAP OF CLAIREMONT PARK UNIT NO. 6A
SUBDIVISION AND ACCEPTING ON BEHALF OF THE
PUBLIC THE PUBLIC STREETS DEDICATED ON SAID
MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by ROY G. ANDERSON, Registered Civil Engineer, and entitled,
"CLAIREMONT PARK UNIT NO. 6A Being a subdivision of portions
of Pueblo Lots 1205 and 1212 of the Pueblo Lands of San Diego
in the City of San Diego, County of San Diego, State of
California, according to the Map thereof made by James Pascoe
in May, 1870, a copy of which was filed in the San Diego
County Recorder's office November 14, 1921, and is known as
Miscellaneous Map No. 36.", is made in the manner and form
prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is
hereby approved and accepted; and said Council hereby accepts
on behalf of the public the public streets, to wit: Mt. Carol
Drive and Acworth Avenue for public purposes and said streets
are hereby declared to be public streets and dedicated to
the public use.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
said public streets are accepted on behalf of the public as
heretofore stated.

Said City Clerk is hereby directed to transmit said map
to the Clerk of the Board of Supervisors of the County of
San Diego, California.
