

RESOLUTION NO. 201368 DEC 3 1970

APPROVING MAP OF LOMA MANOR UNIT NO. 1 SUBDIVISION  
AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO  
THE ABUTTERS' RIGHTS OF ACCESS AS GRANTED ON THIS

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed  
by VICTOR T. WIGLESWORTH, Registered Civil Engineer, and  
entitled, "LOMA MANOR UNIT NO. 1 Being a subdivision of  
a portion of Lot 4 of the East Half of Pueblo Lot 1215 of the  
Pueblo Lands of San Diego, in the City of San Diego, County  
of San Diego, State of California, according to Partition  
Map in the Superior Court Suit No. 17586, a certified copy  
of the Decree in said Suit having been filed in the Recorder's  
Office in Book 608, Page 209 of Deeds.", is made in the manner  
and form prescribed by law and conforms to the surrounding  
surveys; that said map and the subdivision of land shown  
thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council accepts on behalf  
of The City of San Diego, a municipal corporation, any and all  
abutters' rights of access in and to Linda Vista Road and  
Baltic Street, adjacent and contiguous to portions of Lot 1,  
as granted and shown on said map.
