BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with GLENN A. RICK ENGINEERING AND DEVELOPMENT CO., INC. for the design of certain portions of the SAN DIEGO WILD ANIMAL PARK and the coordination of the engineering services to be done by other architects and engineers, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 734170.

BE IT FURTHER RESOLVED, that the City Auditor is hereby authorized to transfer \$200,000 from Capital Outlay Fund 245 to be made available for preliminary costs in connection with the San Diego Wild Animal Park Development; said sum to be returned to Capital Outlay Fund 245 from Bond Fund when bonds are sold.
