BE IT RESOLVED by the Council of The City of San Diego  
as follows:

That the City Manager be and he is hereby authorized  
and empowered to execute for and on behalf of said City, an  
agreement with the National Cash Register Company for the  
purchase and installation of a National Cash Register Century  
200 Automatic Data Processing System, under the terms and  
conditions set forth in that letter of intent on file in the  
office of the City Clerk as Document No. 732267, and NCR  
Computer Purchase Agreement on file in the office of the City  
Clerk as Document No. 734158.

BE IT FURTHER RESOLVED, that the City Auditor and  
Comptroller be and he is hereby authorized to transfer  
\$24,838.54 from the Community Buildings and Improvement Bond  
Fund 726, \$59,997 from the Water Revenue Fund 502, and  
\$19,999 from the Sewer Revenue Fund 506 to the Command and  
Control System Special Revenue Fund 2704 for the sole and  
exclusive purpose of providing funds for the purchase of the  
above system.

BE IT FURTHER RESOLVED, that the expenditure of  
\$354,834.54 out of the Special Revenue Fund 2704 of The City  
of San Diego is hereby authorized, solely and exclusively  
for the above purposes.
