


RESOLUTION No. 201375

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$117,599.00 by Robert H. Johnson, an individual dba Bo-Mar Construction Company, for the CONSTRUCTION OF BELT STREET SEWER in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 733813.
2. That the expenditure of \$142,100.00 is hereby authorized out of the Sewer Revenue Fund (506) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF BELT STREET SEWER in the City of San Diego, and related costs.
