2. That the expenditure of \$900,000.00 is hereby authorized out of the Penasquitos Sewer Bonds, 1970 Improvement Fund (730) of the City of San Diego solely and exclusively for the purpose of providing funds for the SORRENTO-ROSE CANYON INTERCEPTOR - SCHEDULE IV ONLY (ALTERNATE "B") in the City of San Diego, and related costs.
