WHEREAS, Section 21.04 of the San Diego Municipal Code provides for certain holidays in The City of San Diego; and

WHEREAS, the Code makes no provision for what is to happen when any of the named holidays fall on a Saturday; and

WHEREAS, the Council of The City of San Diego by Council Policy 300-3 has expressed its desire to clarify this situation; and

WHEREAS, such policy provides that the City Council, upon advice of the Personnel Advisory Council, shall specify a substitute day as a holiday for any of the holidays falling on a Saturday; and

WHEREAS, the Personnel Advisory Council has submitted a report to the City Council advising the City Council of the days recommended to be substituted as holidays for the specified holidays falling on a Saturday within the fiscal year 1971-72; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That Friday, November 26, 1971, the day following Thanksgiving Day, be an authorized holiday in lieu of Saturday, January 1, 1972, New Years Day.

2. That Friday, December 24, 1971 be an authorized holiday in lieu of Saturday, December 25, 1971, Christmas Day.
