RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO
DECLARING THE RESULTS OF THE CANVASS OF THE SPECIAL
MUNICIPAL ELECTION HELD ON NOVEMBER 3, 1970, ON
TWO PROPOSITIONS TO AMEND THE CITY CHARTER.

WHEREAS, this Council by Ordinance No. 10365 (New Series) adopted August 18, 1970, called a Special Municipal Election to be held in the City on November 3, 1970; and

WHEREAS, this Special Municipal Election was duly consolidated with the Statewide General Election held upon the same date; and

WHEREAS, the Special Municipal Election was held on November 3, 1970, for the purpose of submitting to the qualified electors of the City two propositions to amend the Charter of The City of San Diego, as follows:

PROPOSITION C. CITY OF SAN DIEGO CHARTER
AMENDMENT: AMEND SECTIONS 12 AND 24 OF
THE CHARTER OF THE CITY OF SAN DIEGO.

Amend Section 12 and 24 to provide that the Mayor and Councilmen shall not engage in any business or transaction or have a financial or other personal interest, direct or indirect, which is incompatible with the proper discharge of their duties or which would tend to impair their independence of judgment or action in the performance of such duties, and that the rate of pay for the Mayor shall be Fifteen Hundred Dollars per month, and the rate of pay for each additional Councilman shall be Seven Hundred Fifty Dollars per month.

PROPOSITION E. CITY OF SAN DIEGO CHARTER
AMENDMENT: AMEND SECTIONS 70 AND 130 OF
THE CHARTER OF THE CITY OF SAN DIEGO.

Amend Section 70 to allow the City Council to revise salaries of City employees at any

time during the fiscal year provided sufficient funds are available and budgeted by deleting certain restrictive language and unnecessary reference to specific officials; and amend Section 130 by deleting language making it mandatory that the Civil Service Commission furnish salary recommendations to the City Council prior to the adoption of the Annual Salary Ordinance.

WHEREAS, a copy of the certificate of the Registrar of Voters of the County of San Diego canvassing the returns of the Special Municipal Election, including absentee votes cast, as certified to the Clerk of the Board of Supervisors, has been duly received; and

WHEREAS, a canvass of the Special Municipal Election has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

1. The total number of votes cast in the City, including absentee votes, is 225,087.

2. The number of votes, including absentee votes, cast for and against each of the two propositions which appeared on the ballot as propositions lettered C and E and the total number of votes cast upon each proposition, including absentee votes, are as follows:

PROPOSITION C:

For	96,653
Against	<u>103,216</u>
Total	199,869

PROPOSITION E:


For	52,564
Against	<u>144,923</u>
Total	197,487

3. Propositions C and E did not receive the affirmative vote of a majority of the qualified voters voting on each proposition and each is hereby declared to have failed.

4. The number of votes cast, including absentee votes, is recorded in the Election Returns Book, which book is a part of the records of this Council.

5. The City Clerk shall make public the results of the canvass of the Special Municipal Election by publication of a copy of this resolution.
