

RESOLUTION NO. 201416 DEC 15 1970

RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO
DECLARING THE RESULTS OF THE CANVASS OF THE SPECIAL
MUNICIPAL BOND ELECTION HELD ON NOVEMBER 3, 1970,
ON ONE GENERAL OBLIGATION BOND PROPOSITION FOR THE
SAN DIEGO WILD ANIMAL PARK RECREATIONAL AND EDUCA-
TIONAL FACILITIES.

WHEREAS, this Council by Ordinance No. 10386 (New Series)
adopted August 27, 1970, called a Special Municipal Bond Election
to be held in the City on November 3, 1970; and

WHEREAS, this Special Municipal Bond Election was duly con-
solidated with the Statewide General Election held upon the same
date; and

WHEREAS, the Special Municipal Bond Election was held on
November 3, 1970, for the purpose of proposing and submitting
to the qualified electors of the City the following proposition
to incur indebtedness and issue bonds in the principal amount
indicated therein as follows:

PROPOSITION B. CITY OF SAN DIEGO WILD ANIMAL
PARK RECREATIONAL AND EDUCATIONAL FACILITIES
BOND PROPOSAL: to improve, develop and
expand the area of the San Pasqual Valley
known as the San Diego Wild Animal Park,
shall the City incur a bonded indebtedness
in the principal amount of Six Million
Dollars to permit the acquisition, con-
struction and completion of facilities
to provide recreational, educational,
scientific, ecological and research facil-
ities in harmony with the open space concept
of the valley?

WHEREAS, a copy of the certificate of the Registrar of
Voters of the County of San Diego canvassing the returns of the

Special Municipal Bond Election, including absentee votes cast, as certified to the Clerk of the Board of Supervisors, has been duly received; and

WHEREAS, a canvass of the Special Municipal Bond Election has been completed and the City Clerk has certified the results to the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council finds and determines pursuant to the provisions of Section 27.2206 of the San Diego Municipal Code, as follows:

1. That a Special Bond Election was duly called and regularly held in the City of San Diego on the 3rd day of November, 1970, at which election there was submitted to the qualified voters of said City the following proposition, to wit:

PROPOSITION B. CITY OF SAN DIEGO WILD ANIMAL PARK RECREATIONAL AND EDUCATIONAL FACILITIES BOND PROPOSAL: to improve, develop and expand the area of the San Pasqual Valley known as the San Diego Wild Animal Park, shall the City incur a bonded indebtedness in the principal amount of Six Million Dollars to permit the acquisition, construction and completion of facilities to provide recreational, educational, scientific, ecological and research facilities in harmony with the open space concept of the valley?

2. That the returns of said election have been duly and regularly canvassed as provided by law and all absentee ballots have been canvassed as provided by law and that the results of such canvass have been certified to this Council by the City Clerk.

3. That the total number of votes cast in the City, including absentee votes, is 225,087.

4. That the number of votes cast, including absentee votes cast, for and against the bond proposition which appeared on the ballot as proposition lettered B, and the total number of votes cast upon the bond proposition, including absentee votes, is as follows:



TOTAL	208,472

5. That the votes of more than two-thirds of all the voters voting at said election upon said bond proposition were cast in favor of the adoption of said bond proposition, and said bond proposition is hereby declared to be carried, and this City Council is authorized to issue bonds for the purpose stated therein as provided by law.

6. That the number of votes cast for and against the proposition, including absentee votes, is recorded in the Election Returns Book of The City of San Diego, which book is a part of the records of this Council.

7. That the City Clerk shall make public the results of the canvass of the Special Municipal Bond Election by a publication of a copy of this resolution.
