RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO, CALIFORNIA, AWARDING
CONTRACT.

(Harbor View Drive, et al, Assessment
District)

WHEREAS, in proceedings under the Municipal Improvement Act of 1913 the Council adopted Resolution No. 200973 ordering the giving of notice inviting sealed bids for the construction of the improvements described in the Report of the City Engineer and approved by Resolution No. 200972, and said notice has been duly published; and

WHEREAS, at the time and place fixed, all sealed bids for said construction which were filed with the City Clerk were publicly opened, examined and declared and a report of the results of said bidding submitted to the Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The bid of Wilcox Electric dba ARROW ELECTRIC,

is the lowest bid for said construction by any responsible bidder and is accompanied by a good and sufficient bid check or bond which is satisfactory to the Council. Said bid is hereby accepted and the contract for said construction awarded to the above-named bidder at the prices named in said bid.

Section 2. All bids, other than the bid above accepted, are hereby rejected and the City Clerk is directed to return to each bidder whose bid is so rejected the check or bond which accompanied his bid.
