BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Ninth Amendment to Lease Agreement with PSA HOTELS, INC., a wholly owned subsidiary of Pacific Southwest Airlines, a California corporation, as lessee, amending that certain Lease Agreement which is on file in the office of the City Clerk as Document No. 516032, as assigned by assignment filed in the office of the City Clerk as Document No. 730595, as amended, to extend the period in which the rental rate of 5% of the first \$200,000.00 per year of gross income from the sale of sport-fishing and sightseeing boat tickets remains in effect retro-active from April 1, 1970 through May 31, 1971, under the terms and conditions set forth in the form of Ninth Amendment to Lease Agreement, on file in the office of the City Clerk as Document No. 734286.
