

RESOLUTION NO. 201460 DEC 17 1970

WHEREAS, the Economic Opportunity Commission of San Diego County has been directed by the Regional Department of Health, Education, and Welfare to reduce the Head Start program budget by 13.45 percent; and

WHEREAS, in order to adjust to this cutback in funds Head Start will be forced to reduce by 300 the number of children served; and

WHEREAS, Head Start is designed to give the underprivileged child a "head start" prior to entering elementary school, thus eliminating the need for remedial programs later; and

WHEREAS, Head Start parents and supporters, including the "Committee to Save 300" are greatly concerned and opposed to this possible reduction of children being served by this valuable program; NOW, THEREFORE,

BE IT RESOLVED by the Council of The City of San Diego as follows:

That said Council supports the Economic Opportunity Commission of San Diego County in its efforts to maintain its current level of funding.
