

RESOLUTION NO. 201461

DEC 17 1970

WHEREAS, by Resolution No. 174850 adopted March 12, 1963, the City Council authorized the Director of Utilities to furnish water to the V. R. Dennis Construction Co., 7000 Mission Gorge Road, which is located outside the limits of the City of San Diego; and

WHEREAS, the authorization was limited to a period of one year and was subsequently extended for one-year periods by Resolution No. 179553 adopted April 7, 1964; Resolution No. 182773 adopted February 4, 1965; Resolution No. 186902 adopted April 7, 1966; Resolution No. 189848 adopted March 23, 1967; Resolution No. 193320 adopted April 2, 1968, and was subsequently extended for a period of six months by Resolution No. 196982 adopted May 20, 1969; Resolution No. 198266 adopted October 21, 1969; and Resolution No. 200023 adopted June 16, 1970; and

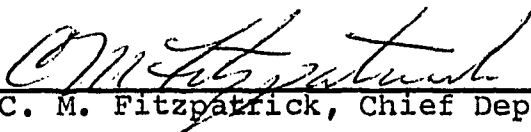
WHEREAS, the V. R. Dennis Construction Co. requires water service to fulfill its contracts with the City and other public agencies; and

WHEREAS, the Director of Water Utilities (formerly the Director of Utilities) recommends that the City furnish water for an additional six months; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager is authorized to furnish water to the V. R. Dennis Construction Co., 7000 Mission Gorge Road, for a period of six months commencing October 21, 1970, at amounts not to exceed 7,500 cubic feet per month at standard out-of-city rates.
