BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City of San Diego, operating through its

Recreation Department under the direction of the City

Manager hereby assumes full responsibility for the implementation and operation of the Demonstration Recreation

Project of the San Diego Model Cities Program.

BE IT FURTHER RESOLVED, that to the extent permitted by law and its Charter, the City shall operate said Project

in accordance with the terms and conditions specified in the Operating Agency Agreement as modified by additions and interlineations and in accordance with the attachments thereto, which together with said agreement are on file 734301 in the office of the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the Project budget in the amount of \$200,000.00 is hereby approved and the expenditure of \$200,000 is hereby authorized out of Model Cities First Action Year Fund 2901 of The City of San Diego, solely and exclusively for the purpose of providing funds for the operation of said project.
