WHEREAS, this Council has reviewed said recommendations as well as the suggestions presented; NOW THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

William R. Halley	POLICE DEPARTMENT	\$210	Patrolman Halley suggested about two years ago that Municipal Code Sections 33.2401 - 33.2410 regarding the licensing of vehicles for hire without driver be changed. This was done November 3, 1970. This eliminates a costly, time-consuming procedure involving several departments that Halley recognized as being unnecessary. The procedure is much improved for those seeking such licenses too. An estimated \$2,100 a year in the time of several people is saved.
