

RESOLUTION NO. 201491 DEC 22 1970

APPROVING MAP OF PIAZZA SUBDIVISION AND ACCEPTING
ON BEHALF OF THE CITY OF SAN DIEGO THE EASEMENT
GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by W.D. HARGUS, Registered Civil Engineer, and entitled, "PIAZZA
SUBDIVISION Being a subdivision of Lots 4, 5, 6, and 7, Block 35,
of Western Addition, Map 315, filed in the office of the San
Diego County Recorder, May 15, 1870, together with Yonge Street
closed adjacent thereto in the City of San Diego, County of San
Diego, State of California.", is made in the manner and form
prescribed by law and conforms to the surrounding surveys; that
said map and the subdivision of land shown thereon is hereby
approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on
behalf of The City of San Diego, a municipal corporation, the
easement with the right of ingress and egress for the construction
and maintenance of drainage facilities as granted and shown on
said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to
endorse upon said map as and for the act of the Council that said
Council has approved said subdivision map and that that certain
easement with the right of ingress and egress for the construction
and maintenance of drainage facilities as granted and shown on
this map within this subdivision is accepted on behalf of The City
of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the
Clerk of the Board of Supervisors of the County of San Diego,
California.
