1 SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC PORTION OF PUBLIC STREET DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO, THE EASEMENTS GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GUY W. WINTON, JR., Registered Civil Engineer, and entitled, "PACIFIC COAST PROPERTIES UNIT NO. 1 Being a subdivision of a portion of Pueblo Lot 1120 of the Pueblo Lands of San Diego in the City of San Diego, County of San Diego, State of California, according to Map thereof Made by James Pascoe in 1870.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portion of public street, to wit: a portion of Hotel Circle, for public purposes, and said portion of street is hereby declared to be portion of public street and dedicated to the public use.
