The City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of City, an agreement with MESA SHOPPING CENTER, a general partnership, for the construction of improvements on Mira Mesa Boulevard within the limits of the subdivision, in MIRA MESA SHOPPING CENTER UNIT NO. 1 subdivision, and to provide for reimbursement by the City, out of Gas Tax Fund 219, in an amount not to exceed \$26,672.00, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 734317.
