

RESOLUTION No. 201524

Adopted on DEC 24 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF TWO HOURS, between the hours of 8:00 a.m. and 6:00 p.m., Sundays and certain holidays excepted, be and the same is hereby established on the following streets in said City:

Both sides of AVENIDA DE LA PLAYA between El Paseo Grande and Paseo Del Ocaso, on the west side of PASEO DEL OCASO between Avenida de la Playa and Calle Clara, and on the east side of EL PASEO GRANDE between Avenida de la Playa and Calle Clara.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same are hereby authorized to be made on said streets, and that the regulations hereinabove imposed shall become effective upon the installation of such signs.
