elementary, junior and senior high schoolstudents who have not yet reached their
eighteenth birthday to play a maximum of
eighteen holes of golf on weekdays only,
subject to rules and regulations of
management on any municipal golf course.
Student tickets may also be issued to
members of any golf team representing
collegiate level institutions located
in San Diego, for the competitive golf
season only.

BE IT FURTHER RESOLVED, that the Recreation Department is hereby authorized to select five (5) "home" student golf teams of six (6) members each from junior high schools, senior high schools and colleges in the City of San Diego for play at Balboa Park and the same number for play at Torrey Pines. Subject to scheduling by the course management, with each team member required to purchase a student monthly ticket, match contests may be arranged at both courses between such student teams and student teams of like number of members from "visiting" teams chosen from other junior and senior high schools or colleges and further, to arrange reciprocal

waiving of green fees and the reciprocal honoring of monthly student tickets with their respective "home" courses, provided that team matches shall start at the discretion of the course management, are limited to one match of two teams on any school day except Wednesday when there shall be no team matches.

BE IT FURTHER RESOLVED, that the Recreation Department is hereby authorized to arrange for the waiving of green fees for contestants entered in the annual Junior Golf Championships held at any municipal golf course.

BE IT FURTHER RESOLVED, that for the purpose of this resolution, legal holidays are as follows: New Year's Day, Memorial Day, Independence Day, Labor Day, Veterans' Day, Thanksgiving Day and Christmas Day.

BE IT FURTHER RESOLVED, that Resolution No. 185584, adopted November 23, 1965, be and the same is hereby rescinded.

BE IT FURTHER RESOLVED, that this resolution shall become effective on the first day of the month following the thirtieth day after its passage.
