BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the City Manager be and he is hereby authorized to make an offer to the Pomerado County Water District for sewerage services under the following terms and conditions:

1. Said District would acquire capacity rights in the Penasquitos Sewer District and the Metropolitan Sewer System of two million gallons per day.
2. Said District would pay an initial cash contribution of \$2,233,000 for capacity rights in the Penasquitos Sewer District.
3. Said District would pay \$66,162 per year for capacity rights in the Metropolitan Sewer System with said payment to extend to the year 2003.
4. Said District would pay its prorated share of the maintenance and operation costs of both the Penasquitos Sewer District and the Metropolitan Sewer System as computed annually, plus a 100% surcharge.
5. If the area served by said District were to be formed into an incorporated city within five years, the 100% surcharge on maintenance and operation as set forth above would be eliminated.

6. If the area served by said District were to be annexed to the City of San Diego, the maintenance and operation charge and the Metropolitan Sewer System capacity charges would be eliminated and normal city sewer service charges would be imposed on all serviceable properties in said annexed area.
