

RESOLUTION NO. 201562 ADOPTED December 30, 1970

RESOLUTION OF THE COUNCIL OF THE CITY
OF SAN DIEGO, CALIFORNIA, AWARDED
IMPROVEMENT BONDS.

(Centre City Way Assessment District)

WHEREAS, the Council adopted Resolution No. 201168 ordering the giving of a notice inviting bids for the purchase of all the improvement bonds described therein and said notice has been duly published; and

WHEREAS, at the time and place fixed, all sealed bids for the purchase of said bonds which were filed with the City Clerk were publicly opened, examined and a report of the results of said bidding submitted to this Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. The bid for said bonds yielding the lowest net interest cost is the bid of R. J. WEILER


_____ offering to purchase said bonds for 98.00001 % of their par value and a premium of \$ 0.00, said bonds to bear interest at the rate of 6.45 % per annum. Said bid is hereby accepted and the bonds awarded to said bidder in accordance with the terms of such bid.

Section 2. All bids other than the bid above accepted are hereby rejected and the City Clerk is directed to return the checks accompanying said rejected bids to the respective bidders.

Section 3. The interest rate on said bonds is hereby fixed at the rate stated in Section 1.

Section 4. The Treasurer is directed to deliver to the successful bidder bonds, in the amounts and at the time and manner provided by law, upon payment by the successful bidder of 98.00001 % of the par value of the bonds delivered, a premium of \$ 0.00, and accrued interest from the date of the bonds to the date of delivery.
