ORDINANCE NO. 10481 JAN 14 1971 (New Series)

AN ORDINANCE INCORPORATING LOTS 19 AND 20, BLOCK 140, UNIVERSITY HEIGHTS, IN THE CITY OF SAN DIEGO, CALIFORNIA INTO RP-1A ZONE, AS DEFINED BY SECTION 101.0418.5 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 8018 (NEW SERIES), ADOPTED DECEMBER 9, 1958, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a parcel map is recorded consolidating Lots 19 and 20, Block 140, University Heights, and provided the conditions as required by the City Engineer in Document No. 734122 are met, the provisions of Section 101.0418.5 of the San Diego Municipal Code shall attach and become applicable to Lots 19 and 20, Block 140, University Heights, which area is designated RP-1A on Zone Map Drawing No. B-2400, filed in the office of the City Clerk as Document No. 734121.

Section 2. That in the event the zoning restrictions shall attach to the said land described in Section 1 of this ordinance, Ordinance No. 8018 (New Series), adopted December 9, 1958, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.
