ORDINANCE NO. 10489 JAN 21 1971 (New Series)

AN ORDINANCE INCORPORATING A PORTION OF PUEBLO LOT 256, OF THE PUEBLO LANDS OF SAN DIEGO, IN THE CITY OF SAN DIEGO, CALIFORNIA INTO M-IA ZONE, AS DEFINED BY SECTION 101.0436 OF THE SAN DIEGO MUNICIPAL CODE AND REPEALING ORDINANCE NO. 85 (NEW SERIES), ADOPTED NOVEMBER 21, 1932 AND ORDINANCE NO. 2009 (NEW SERIES), ADOPTED DECEMBER 10, 1940, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICT: HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That in the event that, within two years of the effective date of this ordinance, a portion of Pueblo Lot 256, of the Pueblo Lands of San Diego, in the City of San Diego, California, designated "M-1A" on Zone Map Drawing No. B-2404, is subdivided and a final subdivision map thereof duly recorded and within such subdivision, provision is made for the installation of public utility services and the dedication of streets, alleys and easements for public use, the provisions of Section 101.0436 of the San Diego Municipal Code shall attach and become applicable to the said subdivided land and the said subdivided land shall be incorporated into M-1A Zone, as described by Section 101.0436, the boundary of such zone to be as indicated on Zone Map Drawing No. B-2404, filed in the office of the City Clerk as Document No. 734229.

Section 2. That in the event the zoning restrictions shall attach to the said subdivided land described in Section 1 of this MICROFILMED

ordinance, Ordinance No. 85 (New Series), adopted November 21, 1932 and Ordinance No. 2009 (New Series), adopted December 10, 1940, of the Ordinances of The City of San Diego be, and the same are hereby repealed insofar as they conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
