AN ORDINANCE AMENDING CHAPTER II, ARTICLE 2
OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING
SECTION 22.0101 RELATING TO COUNCIL MEETINGS.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter II, Article 2 of the San Diego
Municipal Code be amended by amending Section 22.0101 to
read as follows:

SEC. 22.0101 COUNCIL MEETINGS

(a) Regular meetings of the City Council shall be
at 9:30 a.m. of each Tuesday and each Thursday of each
week in the Council Chamber of the City Administration
Building, Community Concourse, in the City of San Diego,
California. In the event the regular meeting day shall
fall on a legal holiday, the said meeting shall be held
at 9:30 a.m. of the next business day.

(b) The Council may by resolution, when necessary,
change the time and place of regular meetings. The
resolution shall set forth the circumstances necessitating
such change, the time and place of the meetings and the
duration of such change. Such resolution shall be
published once in the City official newspaper at least
twenty-four (24) hours prior to the first meeting to be
held pursuant to such change.

(c) Twenty-four (24) hours prior to the first meeting to be held pursuant to such change, the City Clerk shall give each Councilman written notice, personally or by registered mail, of any change from the regular meeting days established by this section.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
