

ORDINANCE NO. 10503
(New Series)

AN ORDINANCE AMENDING CHAPTER VIII, ARTICLE 5 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 85.25 RELATING TO OVERLOAD MOVING--PERMIT FEES.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Chapter VIII, Article 5 of the San Diego Municipal Code be amended by amending Section 85.25 to read as follows:

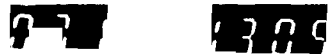
SEC. 85.25 OVERLOAD MOVING--PERMIT FEES

Permit fees required in this Article shall be collected by the City Engineer. Transportation permit fees are herein established as follows:

1. Single-move transportation permit,
standard width \$ 2.00
2. Single-move transportation permit,
extra width \$10.00
3. Continuing transportation permit for
a period up to six (6) months:
 Self-propelled vehicles \$10.00
 Nonself-propelled vehicles. \$30.00
4. Duplicate copies of continuing
transportation permit, each. \$ 1.00

Governmental agencies, including the State of California and any of its political subdivisions,

shall make application for permits under the provisions of this Article and shall be issued a no-fee permit in accordance with the provisions herein. A contractor working for a governmental agency shall not be considered to be acting on behalf of that governmental agency and shall not be exempt from the payment of fees.

An extension of the effective date or an amendment to a single-move permit may be made without payment of additional fees if approved by the City Engineer, provided that the request for such extension or amendment is received before the expiration of the permit.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.

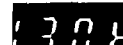
