AN ORDINANCE AMENDING ORDINANCE NOS. 10375 THROUGH 10384 (NEW SERIES), RELATING TO THE COMMERCIAL ZONES, AND ORDINANCE NO. 10452 (NEW SERIES), RELATING TO THE REZONING OF THE ENCANTO AREA.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Section 4 of Ordinance No. 10375 (New Series), and Section 2 of Ordinance Nos. 10376 through 10384 (New Series), relating to the Commercial Zones, be, and they are hereby amended to read as follows:

This ordinance shall take effect and be in force on March 1, 1971, being a date more than 30 days from and after its passage, and no permits for construction, alteration or repair of any building or structure which does not conform with this ordinance shall be issued unless the application and all plans therefor have been filed prior to the effective date set forth above.

Section 2. That Section 3 of Ordinance No. 10452 (New Series), relating to the rezoning of the Encanto Area, be, and it is hereby amended to read as follows:

This ordinance shall take effect and be in force on the thirtieth day from and after its passage, and no permits for construction, alteration or repair of any building or structure which does not conform with this ordinance shall be issued unless the application and all plans therefor have been filed prior to the effective date set forth above.
