pursuant to the provisions of Article 1, Chapter 5,  
Division 7, Title 1 (commencing with Section 6500) of the  
Government Code of the State of California relating to the  
joint exercise of powers common to City and County, creating  
the San Diego Planetarium Authority, under the terms and  
conditions set forth in the form of a Joint Exercise of  
Powers Agreement on file in the office of the City Clerk as  
Document No. 735171.

Section 2. This ordinance shall take effect and be in  
force on the thirtieth day from and after its passage.


