AN ORDINANCE AMENDING ORDINANCE NO. 10300 (NEW SERIES), AS AMENDED, TO CREATE THE CLASSIFIED POSITION OF NEIGHBORHOOD RECREATION SPECIALIST AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego as follows:

Section 1. Ordinance No. 10300 (New Series) of the ordinances of The City of San Diego, as amended, is hereby amended to create and establish the classified position of Neighborhood Recreation Specialist.

Section 2. As the schedule of compensation for the position created in Section 1 hereof, the following standard rate number of the Table of Standard Rates of pay established and adopted by Ordinance No. 10300 (New Series), as amended, of the ordinances of said City, is hereby adopted.

Section 3. The position of Neighborhood Recreation Specialist shall be inserted in Exhibit B of Ordinance No. 10300 (New Series), as amended, under the general category of RECREATION between the positions of Senior Recreation Leader and Intermediate Recreation Leader.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
