AN ORDINANCE AMENDING SECTIONS 1 AND 2 OF ORDINANCE NO. 10093 (NEW SERIES), ADOPTED JULY 17, 1969, INCORPORATING LOT 4, SOUTH SAN DIEGO PARK ACRES, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-3 ZONE AS DEFINED BY SECTION 101.0411 OF THE SAN DIEGO MUNICIPAL CODE.

WHEREAS, Ordinance No. 10093 (New Series), adopted July 17, 1969, rezoned Lot 4, South San Diego Park Acres, from Zone R-1-5 to R-3, subject to the recordation of a final subdivision map within two years; and

WHEREAS, a request has been received to amend this ordinance to delete the subdivision map requirement; NOW, THEREFORE,

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Sections 1 and 2 of Ordinance No. 10093 (New Series), adopted July 17, 1969 be, and they are hereby amended to read as follows:

Section 1. That Lot 4, South San Diego Park Acres, in the City of San Diego, California, within the boundary of the district designated "R-3" on Zone Map Drawing No. B-2116, filed in the office of the City Clerk under Document No. 728415 be, and it is hereby incorporated into R-3 Zone, as such zone is described and defined by Section 101.0411 of the San Diego Municipal Code.

the same conflicts herewith.

Section 3. This ordinance shall take effect and be in
