AN ORDINANCE ADDING ANNEXED TERRITORY, DESIGNATED AS "COLLEGE CREST ANNEXATION," TO COUNCIL DISTRICT NO. 8, PURSUANT TO THE PROVISIONS OF SECTION 5, ARTICLE II OF THE CITY CHARTER.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That the area designated as COLLEGE CREST ANNEXATION in Resolution 202080, adopted March 4, 1971, is hereby added to Council District No. 8, heretofore shown and delineated on that certain map showing the boundary line of said district, as contained in Document No. 727206 on file in the office of the City Clerk of said City, and which district was defined and which map was approved by Ordinance No. 9984 (New Series), of the Ordinances of The City of San Diego, adopted February 27, 1969.

Section 2. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
