AN ORDINANCE AMENDING ORDINANCE NO. 10300 (NEW SERIES), AS AMENDED, TO CREATE THE UNCLASSIFIED POSITION OF ASSISTANT TO THE CITY MANAGER AND ESTABLISH A SCHEDULE OF COMPENSATION THEREFOR.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. Ordinance No. 10300 (New Series) of the ordinances of The City of San Diego, as amended, is hereby amended to create and establish the unclassified position of Assistant to the City Manager.

Section 2. As the schedule of compensation for the position created in Section 1 hereof, the following standard rate number of the Table of Standard Rates of pay established and adopted by Ordinance No. 10300 (New Series), as amended of the ordinances of said City, is hereby adopted.

Section 3. The position of Assistant to the City Manager shall be inserted in Exhibit C of Ordinance No. 10300 (New Series), as amended, between the positions of Deputy Police Chief and Assistant Planning Director.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
