AN ORDINANCE INCORPORATING LOTS A THROUGH L, RESEARCH PARK, PORTIONS OF LOTS 7, 8, 9, 19 AND 20, NEW RIVERSIDE, LOTS 1 THROUGH 11, RESEARCH PARK SUBDIVISION ADDITION, PORTION OF LOT 9, BLOCK 3, AND PORTIONS OF LOTS 1, 6, 7, AND 8, BLOCK 4, ROSEDALE, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-5 AND M-IP ZONES, AS DEFINED BY SECTIONS 101.0407 AND 101.0435.1, RESPECTIVELY, OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 9746 (NEW SERIES), ADOPTED JANUARY 9,1968, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Lots A through L, Research Park, portions of Lots 7, 8, 9, 19, and 20, New Riverside, Lots 1 through 11, Research Park Subdivision Addition, portion of Lot 9, Block 3, and portions of Lots 1, 6, 7, and 8, Block 4, Rosedale, in the City of San Diego, California, within the boundary of the districts designated "R-1-5" and "M-IP" on Zone Map Drawing No. B-2234.1 filed in the office of the City Clerk under Document No. 734944 be, and they are hereby incorporated into R-1-5 and M-IP Zones, as such zones are described and defined by Sections 101.0407 and 101.0435.1, respectively, of the San Diego Municipal Code.

Section 2. That Ordinance No. 9746 (New Series), adopted January 9, 1968, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.
