BE IT ORDAINED by the Council of The City of San Diego as follows:

Section 1. That Chapter IV, Article 4 of the San Diego Municipal Code be and the same is hereby amended by amending Section 44.0328 to read as follows:

SEC. 44.0328 DOG LICENSES--FEE ESTABLISHED AND COLLECTED

The license fee for dogs shall be those fees now or hereafter established by the Board of Supervisors of the County of San Diego.

All fees shall be collected by the County of San Diego by County personnel or deputized City personnel. If fees are mailed, they should be sent to the County of San Diego, County Tax Collector.

Section 2. That Chapter IV, Article 4 of the San Diego Municipal Code be and the same is hereby amended by amending Section 44.0328.1 to read as follows:

SEC. 44.0328.1 DOG LICENSES--PENALTIES

License penalty fees shall be those set by the Board of Supervisors of the County of San Diego.
