AN ORDINANCE INCORPORATING PORTIONS OF PUEBLO LOTS 1210, 1223, 1224, 1227, 1228, 1236, 1229 AND A PORTION OF BLOCK 14 CC.C. TATUM'S BAY HILLS MESA, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-15 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 13456, APPROVED FEBRUARY 15, 1932, AND ORDINANCE NO. 100 (NEW SERIES), ADOPTED DECEMBER 12, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICT HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That portions of Pueblo Lots 1210, 1223, 1224, 1227, 1228, 1236, 1229 and a portion of Block 14, C. C. C. Tatum's Bay Hills Mesa, in the City of San Diego, California, within the boundary of the district designated "R-1-15" on Zone Map Drawing No. B-2427.1, filed in the office of the City Clerk under Document No. 735178 be, and they are hereby incorporated into R-1-15 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 13456, approved February 15, 1932, and Ordinance No. 100 (New Series), adopted December 12, 1932, of the Ordinances of The City of San Diego be, and they are hereby repealed insofar as the same conflict herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
