AN ORDINANCE AMENDING CHAPTER X, ARTICLE 2,
DIVISION 8, SECTION 102.0802, OF THE SAN DIEGO
MUNICIPAL CODE, RELATING TO THE APPLICATION OF
PROVISIONS FOR CONTRIBUTION OF LANDS AND/OR
PAYMENT OF FEES FOR PARK AND RECREATIONAL
FACILITIES IN SUBDIVISIONS.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That Chapter X, Article 2, Division 8, Section
102.0802, of the San Diego Municipal Code be, and the same is
hereby amended to read as follows:

SEC. 102.0802 APPLICATION

The provisions of this Division shall apply
to all subdivision maps and said provisions shall
also apply to those parcel maps which increase the
number of permissible dwelling units as such are
defined in Chapter X, Article 1, of the San Diego
Municipal Code, except industrial subdivisions and
subdivisions for which tentative subdivision maps
have been filed within 30 days after the effective
date of this Division.

Section 2. This ordinance shall take effect and be in
force on the thirtieth day from and after its passage.
