

ORDINANCE NO. 10562 APR 29 1971
(New Series)

AN ORDINANCE INCORPORATING PORTIONS OF PARTITION OF PUEBLO LOT 1209, SUPERIOR COURT CASE 8341, AND PUEBLO LOTS 1224, 1226, 1227, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-15 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 100 (NEW SERIES), ADOPTED DECEMBER 12, 1932, OF THE ORDINANCES OF THE CITY OF SAN DIEGO, INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego,
as follows:

Section 1. That portions of Partition of Pueblo Lot 1209, Superior Court Case 8341, and Pueblo Lots 1224, 1226, 1227, in the City of San Diego, California, within the boundary of the district designated "R-1-15" on Zone Map Drawing No. B-2434.1, filed in the office of the City Clerk under Document No. 735285 be, and they are hereby incorporated into R-1-15 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 100 (New Series), adopted December 12, 1932, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
