

ORDINANCE NO. 10565 MAY 6 1971
(New Series)

AN ORDINANCE INCORPORATING PUEBLO LOT 291 AND PORTIONS OF PUEBLO LOTS 267, 289, 290, 292, 1177 AND 1196, IN THE CITY OF SAN DIEGO, CALIFORNIA, INTO R-1-15 ZONE, AS DEFINED BY SECTION 101.0407 OF THE SAN DIEGO MUNICIPAL CODE, AND REPEALING ORDINANCE NO. 85 (NEW SERIES), ADOPTED NOVEMBER 21, 1932 OF THE ORDINANCES OF THE CITY OF SAN DIEGO INSOFAR AS THE SAME CONFLICTS HEREWITH.

BE IT ORDAINED, by the Council of The City of San Diego, as follows:

Section 1. That Pueblo Lot 291 and portions of Pueblo Lots 267, 289, 290, 292, 1177 and 1196, in the City of San Diego, California, within the boundary of the district designated "R-1-15" on Zone Map Drawing No. B-2345.4, filed in the office of the City Clerk under Document No. 735704 be, and they are hereby incorporated into R-1-15 Zone, as such zone is described and defined by Section 101.0407 of the San Diego Municipal Code.

Section 2. That Ordinance No. 85 (New Series), adopted November 21, 1932, of the Ordinances of The City of San Diego be, and it is hereby repealed insofar as the same conflicts herewith.

Section 3. This ordinance shall take effect and be in force on the thirtieth day from and after its passage.
